



AMNESTY INTERNATIONAL NIGERIA'S REPORT: "WE DRIED OUR TEARS, ADDRESSING THE TOLL ON CHILDREN OF NORTHEAST NIGERIA'S CONFLICT "

Amnesty International Nigeria is happy to share with you its report "We Dried Our Tears: Addressing the Toll on Children of Northeast Nigeria's Conflict".

This report, which is based on research conducted by Amnesty International between November 2019 and April 2020 was launched on 27 May 2020. The report which builds on a decade of Amnesty International's work on the conflict in Northeast Nigeria, examines how children fleeing Boko Haram-controlled areas, including former child soldiers, are overwhelmingly victims of serious human rights abuses, including war crimes and crimes against humanity. It also examines how the military's widespread use of unlawful detention and torture has compounded the suffering of the children.

The report further reveals the negative and positive elements of the Operation Safe Corridor, a demobilization, disassociation, rehabilitation, and reintegration (DDRR) programme coordinated by the Defence Headquarters. It finally focuses on lack of access to education for children displaced from Boko Haram-controlled areas.


